#### RIVAGE PM10 Series Editor/Firmware Compatibility

*Please make sure to match all versions of CS-R10, DSP-R10, RPio622, RPio222 and RIVAGE PM10 Editor when you operate the RIVAGE PM10 system. Using an unsupported Editor/firmware combination may result in unexpected behavior.*

*When updating, make sure to insert the TWINLANe network card (HY256-TL) beforehand, since the card will also be updated. If you have inserted the card after updating, perform the update again.*
